RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1302223CV, Klamath County Sheriff's Office Number J14-0086, in which PNC BANK, NATIONAL ASSOCIATION was plaintiff(s) and MALEAH R. 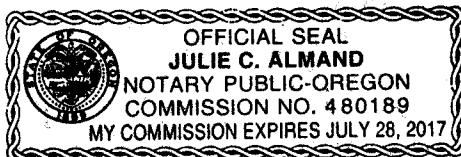
