RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1300679CV, Klamath County Sheriff's Office Number J14-0087, in which JPMORGAN CHASE BANK, NATIONAL ASSOCIATION, ITS SUCCESSORS IN INTEREST AND/OR ASSIGNS was plaintiff(s) and JOHN H. CLEMENS; DIANA M. CLEMENS; AND OCCUPANTS OF THE PREMISES was defendant(s), in which a Writ of Execution in Foreclosure, which was issued on 05/05/2014, directing the sale of that real property, pursuant to which, on 8/25/2014 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$50,740.00, to JPMorgan Chase Bank, National Association, who was the highest and best bidder, that sum being the highest and best sum bid therefore. TO HAVE AND TO HOLD the same unto the grantee and grantee's heirs, successors, and assigns forever.

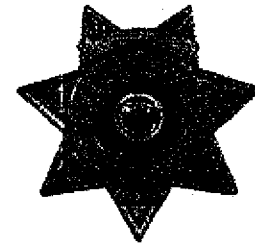

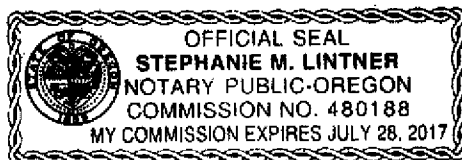


