MODIFICATION OF DEED OF TRUST

THIS MODIFICATION OF DEED OF TRUST dated March 17, 2015, is made and executed between JOHN E. KENNEDY and JEANETTE M. KENNEDY, Trustees under the KENNEDY DECLARATION OF TRUST DATED NOVEMBER 27, 1991, AS TO AN UNDIVIDED 1/3 INTEREST; JOHN ELMER KENNEDY, JR. and FILICITY RAE GERDING-KENNEDY, CO-TRUSTEES, OR THEIR SUCCESSORS IN TRUST, UNDER THE KENNEDY AND GERDING-KENNEDY FAMILY TRUST DATED DECEMBER 4, 2003 AND ANY AMENDMENTS THERETO, AS TO AN UNDIVIDED 1/3 INTEREST AND JOSEPH M. KENNEDY AND CHRISTINA C. KENNEDY, HUSBAND & WIFE AS TO AN UNDIVIDED 1/3 INTEREST, whose address is 709 Rockfellow Drive, Mt. Shasta, CA 96097 ("Grantor") and SCOTT VALLEY BANK, whose address is MT. SHASTA BRANCH, P.O. BOX 279, 142 MORGAN WAY, MT. SHASTA, CA 96067 ("Lender").

DEED OF TRUST. Lender and Grantor have entered into a Deed of Trust dated December 16, 2005 (the "Deed of Trust") which has been recorded in KLAMATH County, State of Oregon, as follows:

THE WORD "NOTE" NOW MEANS PROMISSORY NOTE DATED DECEMBER 16, 2005, ALONG WITH A RENEWAL PROMISSORY NOTE DATED MARCH 17, 2015 IN THE PRINCIPAL AMOUNT OF \$111,445.44, FROM GRANTOR TO LENDER, ALONG WITH ALL RENEWALS OF, EXTENSIONS OF, MODIFICATIONS OF, CONSOLIDATIONS OF AND SUBSTITUTIONS FOR PROMISSORY NOTE OR AGREEMENT. THE MATURITY DATE OF THIS NOTE IS MARCH 5, 2025.

NOTICE TO TRUSTOR: THE NOTE CONTAINS A VARIABLE INTEREST RATE..

CONTINUING VALIDITY. Except as expressly modified above, the terms of the original Deed of Trust shall remain unchanged and in full force and effect. Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Deed of Trust as changed above nor obligate Lender to make any future modifications. Nothing in this Modification shall constitute a satisfaction of the promissory note or other credit agreement secured by the Deed of Trust (the "Note"). It is the intention of Lender to retain as liable all parties to the Deed of Trust and all parties, makers and endorsers to the Note, including accommodation parties, unless a party is expressly released by Lender in writing. Any maker or endorser, including accommodation makers, shall not be released by virtue of this Modification. If any person who signed the original Deed of Trust does not sign this Modification, then all persons signing below acknowledge that this Modification is given conditionally, based on the representation to Lender that the non-signing person consents to the changes and provisions of this Modification or otherwise will not be released by it. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.
