THIS INDENTURE, Made this 1/27/2015, by and between Frank Skrah, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and U.S. Bank, National Association, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1300445CV, Klamath County Sheriff's Office Number J13-0138, in which U.S. Bank, National Association was plaintiff(s) and Fredrick G. Daniel, et al was defendant(s), in which a Writ of Execution of Real Property, which was issued on 11/27/2013, directing the sale of that real property, pursuant to which, on 4/30/2014 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$80,840.00, to U.S. Bank, National Association, who was the highest and best bidder, that sum being the highest and best sum bid therefore. 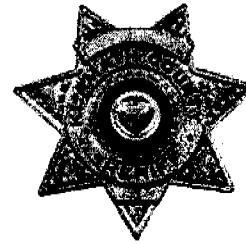

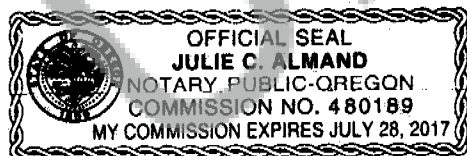
