Reference is made to that certain trust deed made by Tony D Lynch, and Brenda L Lynch, husband and wife, as grantor, to First American Title Insurance Comp, as trustee, in favor of Mortgage Electronic Registration Systems, Inc. as nominee for Decision One Mortgage Company, LLC, its successors and assigns, as beneficiary, dated 03/27/06, recorded 03/31/06, in the mortgage records of Klamath County, Oregon, as M06-06233 and subsequently assigned to Bank of New York Mellon, f/k/a Bank of New York, as Trustee, on behalf of the registered holders of Alternative Loan Trust 2006-OC5, Mortgage Pass-Through Certificates Series 2006-OC5 by Assignment recorded as 2014-008909, covering the following described real property situated in said county and state, to wit: Lot 12 in Block 9, Sun Forest Estates, Tract 1060, according to the official Plat thereof, on file in the office of the County Clerk of Klamath County, Oregon. Both the beneficiary and the trustee have elected to sell the real property to satisfy the obligations secured by the trust deed and a notice of default has been recorded pursuant to Oregon Revised Statutes 86.752(3); the default for which foreclosure is made is grantors' failure to pay when due the following sums: monthly payments of \$841.10 beginning 04/01/11, \$1,025.10 beginning 5/1/11, \$1,025.11 beginning 11/1/11, \$1,025.10 beginning 5/1/12, \$1,025.11 beginning 11/1/12, \$1,025.10 beginning 5/1/13, \$1,025.11 beginning 11/1/13, \$1,025.10 beginning 5/1/14 and \$1,025.11 beginning 11/1/14; plus advances of \$9,720.47 that represent property valuation, property inspections, property preservation and paid foreclosure fees and costs; together with title expense, costs, trustee's fees and attorney's fees incurred herein by reason of said default; any further sums advanced by the beneficiary for the protection of the above described real property and its interest therein; and prepayment penalties/premiums, if applicable.

By reason of said default the beneficiary has declared all sums owing on the obligation secured by the trust deed immediately due and payable, said sums being the following, to wit: \$129,495.51 with interest thereon at the rate of 6.1 percent per annum beginning 03/01/11; plus advances of \$9,720.47 that represent property valuation, property inspections, property preservation and paid foreclosure fees and costs; together with title expense, costs, trustee's fees and attorneys fees incurred herein by reason of said default; any further sums advanced by the beneficiary for the protection of the above described real property and its interest therein; and prepayment penalties/premiums, if applicable.

WHEREFORE, notice hereby is given that the undersigned trustee will on May 27, 2015 at the hour of 10:00 o'clock, A.M. in accord with the standard of time established by ORS 187.110, at the following place: inside the 1st floor lobby of the Klamath County Courthouse, 316 Main Street, in the City of Klamath Falls, County of Klamath, State of Oregon, sell at public auction to the highest bidder for cash the interest in the described real property which the grantor had or had power to convey at the time of the execution by grantor of the trust deed, together with any interest which the grantor or grantor's successors in interest acquired after the execution of the trust deed, to satisfy the foregoing obligations thereby secured and the costs and expenses of sale, including a reasonable charge by the trustee. Notice is further given that for reinstatement or payoff quotes requested pursuant to ORS 86.786 and 86.789 must be timely communicated in a written request that complies with that statute addressed to the trustee's "Urgent Request Desk" either by personal delivery to the trustee's physical offices (call for address) or by first class, certified mail, return receipt requested, addressed to the trustee's post office box address set forth in this notice. Due to potential conflicts with federal law, persons having no record legal or equitable interest in the subject property will only receive information concerning the lender's estimated or actual bid. Notice is further given that any person named in ORS 86.778 has the right, at any time prior to five days before the date last set for the sale, to have this foreclosure proceeding dismissed and the trust deed reinstated by payment to the beneficiary of the entire amount then due (other than such portion of the principal as would not then be due had no default occurred) and by curing any other default complained of herein that is capable of being cured by tendering the performance required under the obligation or trust deed, and in addition to paying said sums or tendering the performance necessary to cure the default, by paying all costs and expenses actually incurred in enforcing the obligation and trust deed, together with trustee's and attorney's fees not exceeding the amounts provided by said ORS 86.778. Requests from persons named in ORS 86.778 for reinstatement quotes received less than six days prior to the date set for the trustee's sale will be honored only at the discretion of the beneficiary or if required by the terms of the loan documents.
