STATUTORY WARRANTY DEED

Grantor(s), hereby convey and warrant to

Shannon G. Steffey ,

Grantee(s), the following described real property in the County of Klamath and State of Oregon free of encumbrances except as specifically set forth herein:

A tract of land 75 feet in width on the North line of Lot 8, Block 92, BUENA VISTA ADDITION to the City of Klamath Falls, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon, described as follows:


