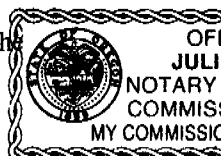

THIS INDENTURE, Made this 5/14/2015, by and between Frank Skrah, Sheriff of Klamath County, Oregon,  
hereinafter called the grantor, and Federal Home Loan Mortgage Corporation, hereinafter called the grantee;

WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1301576CV, Klamath County Sheriff's Office Number J14-0153, in which NATIONSTAR MORTGAGE LLC was plaintiff(s) and DENNIS JUSTICE, AN INDIVIDUAL; TYRA JUSTICE, AN INDIVIDUAL; CARTER-JONES COLLECTION SERVICE, INC, AN OREGON CORPORATION; DISCOVER BANK, A DELAWARE CORPORATION; AND ALL OTHER PERSONS OR PARTIES UNKNOWN CLAIMING ANY LEGAL OR EQUITABLE RIGHT, TITLE, ESTATE, LIEN, OR INTEREST IN THE REAL PROPERTY DESCRIBED IN THE COMPLAINT HEREIN, ADVERSE TO PLAINTIFF'S TITLE, OR ANY CLOUD ON PLAINTIFF'S TITLE TO THE PROPERTY, COLLECTIVELY DESIGNATED AS DOES 1 THROUGH 50, INCLUSIVE was defendant(s), in which a Writ of 1301576CV, which was issued on 6/6/2014, directing the sale of that real property, pursuant to which, on 9/29/2014 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$136,387.37, to Federal Home Loan Mortgage Corporation, who was the highest and best bidder, that sum being the highest and best sum bid therefore. 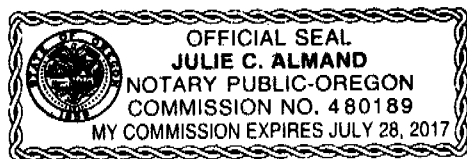


