RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1302478CV, Klamath County Sheriff's Office Number J14-0089, in which WELLS FARGO BANK, NA, ITS SUCCESSORS IN INTEREST AND/OR ASSIGNS was plaintiff(s) and SCOTT J.
