RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1301527CV, Klamath County Sheriff's Office Number J14-0064, in which JPMORGAN CHASE BANK, N.A. SUCCESSOR BY MERGER TO CHASE HOME FINANCE LLC, ITS SUCCESSORS IN INTERST AND/OR ASSIGNS was plaintiff(s) and LORENZO V. MAGANA AKA LORENZO VAZQUEZ MAGANA; LIZBETH H.
