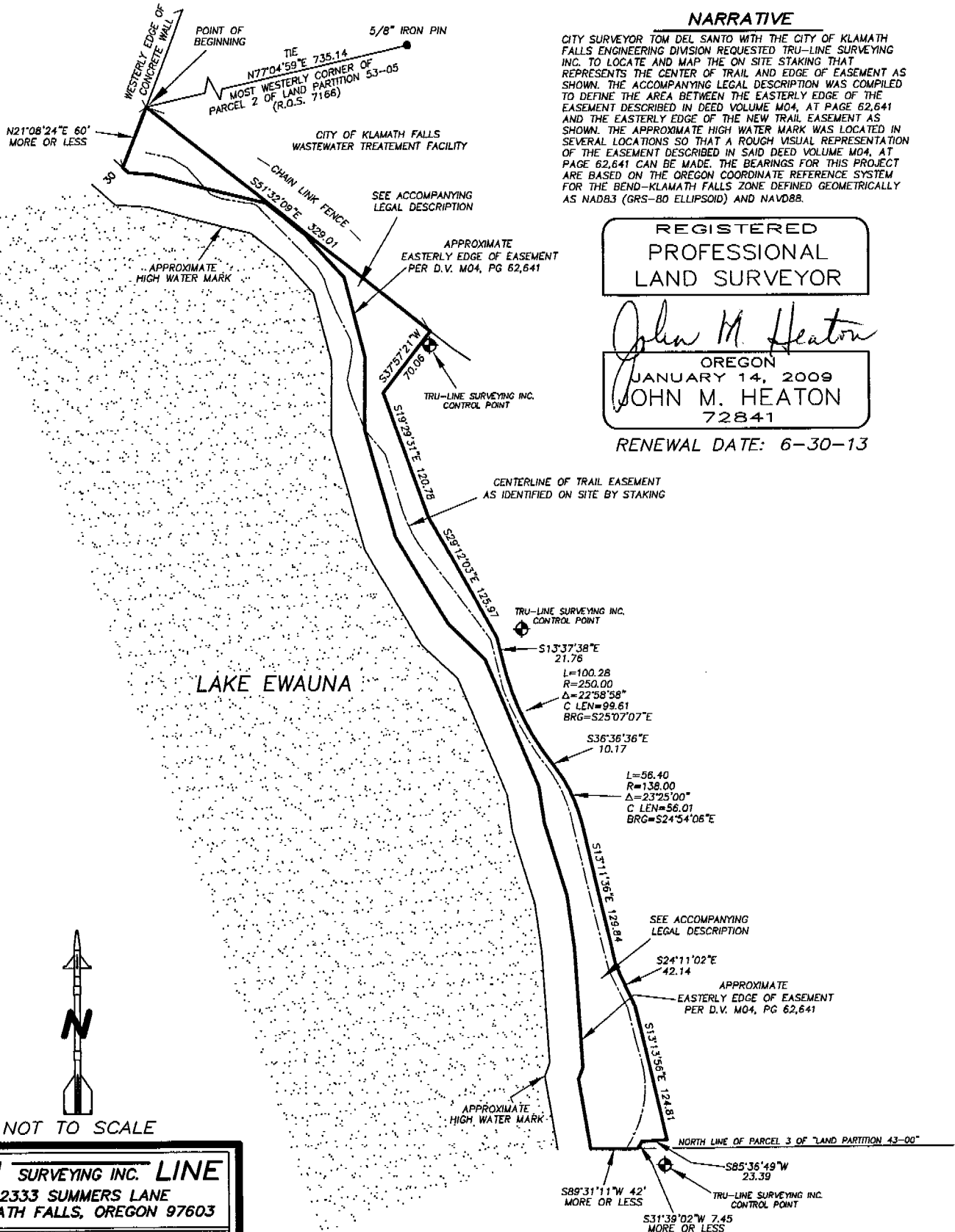
NARRATIVE

CITY SURVEYOR TOM DEL SANTO WITH THE CITY OF KLAMATH FALLS ENGINEERING DIVISION REQUESTED TRU-LINE SURVEYING INC. TO LOCATE AND MAP THE ON SITE STAKING THAT REPRESENTS THE CENTER OF TRAIL AND EDGE OF EASEMENT AS SHOWN. THE ACCOMPANYING LEGAL DESCRIPTION WAS COMPILED TO DEFINE THE AREA BETWEEN THE EASTERLY EDGE OF THE EASEMENT DESCRIBED IN DEED VOLUME M04, AT PAGE 62,641 AND THE EASTERLY EDGE OF THE NEW TRAIL EASEMENT AS SHOWN. THE APPROXIMATE HIGH WATER MARK WAS LOCATED IN SEVERAL LOCATIONS SO THAT A ROUGH VISUAL REPRESENTATION OF THE EASEMENT DESCRIBED IN SAID DEED VOLUME M04, AT PAGE 62,641 CAN BE MADE.
