RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1302517CV, Klamath County Sheriff's Office Number J14-0154, in which WELLS FARGO BANK, N.A. was plaintiff(s) and ESTATE OF LLOYD E. EMIGH, DECEASED; SYDNEY L. 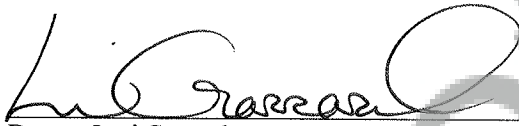

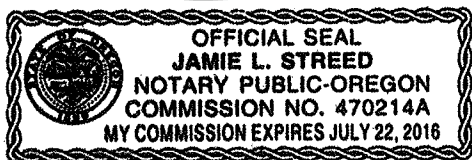

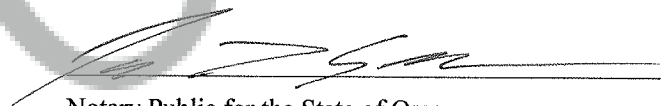
