## EXHIBIT "A" LEGAL DESCRIPTION

A piece or parcel of land situated in the N1/2SE1/4NW1/4 of Section 11, Township 39 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, and more particularly described as follows:

Beginning at a point in the center line of a 60 foot roadway, from which the section corner common to Sections 2, 3, 10 and 11, Township 39 South, Range 9 East of the Willamette Meridian, and as marked on the ground by an iron pin driven therein bears S89°44 1/2' W along the said roadway center line 1682.3 feet to a point in the West boundary of the said Section 11; and N 0°13 1/2' West 1662.5 feet to said section corner, and running thence S 0° 01' East 331.25 feet, to a point in the Southerly boundary of the said N 1/2 SE1/4 NW1/4 of Section 11; thence N 89° 42' East along said boundary line 65.7 feet; thence N 0° 01' W 331.2 feet, more or less, to an intersection with the center line of the above mentioned roadway; thence S 89° 44 1/2' W along said road way center line 65.7 feet, more or less, to the said point of beginning.
