The true and actual consideration for this conveyance is **\$292,500.00**.

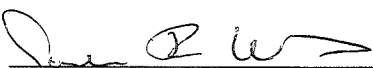

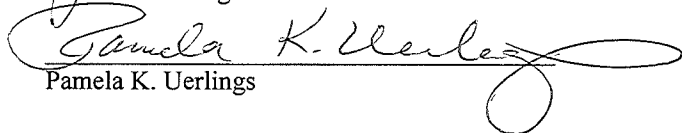
