



Beginning at the Southwest corner of that tract of land described in Deed Volume M72 Page 1623, records of Klamath County, Oregon, which is North 12°14'37" West, 536.95 feet from the S1/4 corner of Section 1; thence North 03°24' West, along the Westerly line of said land 83.2 feet; thence North 23°39'30" East along the Westerly line of that tract of land described in deed Volume M72 Page 1625, records of Klamath County, Oregon, 577.61 feet to the Southerly right of way line of State Highway No. 140; thence North 46°09' West along said right of way 200.00 feet; thence South 43° 51' West, 50.00 feet; thence South 20°27'53" West, 679.84 feet to a point that bears North 67°44' West from the point of beginning; thence South 67°44' 205.00 feet to the point of beginning, with bearings based on recorded survey No. 625, as recorded in the office of the Klamath County Surveyor.
