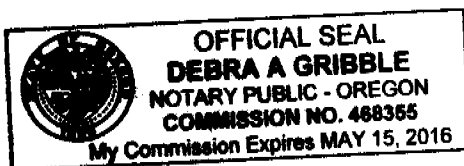

## DEFENDANTS:

1. Plaintiff, Klamath County, Oregon (County), is a fully organized county of the State of Oregon and is duly public and corporate under and by virtue and laws of the State of Oregon and is acting through its tax collector, Rafael Hernandez, pursuant to ORS 312.050.

2. The above named defendants include each and every person appearing on the latest tax roll as the owner or owners of the several properties listed in the enclosed exhibit described below and incorporated herein. These defendants, including any owners unknown to plaintiff, have or claim to have some interest or estate in the several properties described in the enclosed list.

WHEREFORE, Plaintiff prays for judgment of this court, pursuant to ORS 312.050, as follows:

a. For the full amount of taxes and interest, special assessments, fees or other charges charged against each of the several properties included in said foreclosure list, together with interest thereon at the rate of 13.33 percent per month.

The Tax Collector of the County maintains a foreclosure list of all county properties subject to foreclosure for delinquent taxes as of August 18, 2015. The foreclosure list was prepared pursuant to and in accordance with ORS 312.020 and contains all the information required by this statute. All property descriptions are in accordance with ORS 312.040 and ORS 308.240. A copy of the foreclosure list is attached hereto as "Exhibit A" and is by this reference incorporated herein. Where any reference is made to an Assessor's tax lot number in describing any parcel of property in the foreclosure list, such reference is to the record made and kept by the Assessor of Klamath County, Oregon, of descriptions of property for such County, which record constitutes a public record by virtue of ORS 308.215 et seq.

The foreclosure list includes all properties appearing on the tax rolls in the office of the Tax Collector of the County and are applied to foreclosure for delinquent taxes whenever three years have elapsed from the earliest date of delinquency or taxes levied and charged thereon, which have not been paid.
