KNOW ALL MEN BY THESE PRESENTS, That

Barbara A. Dussel.

hereinafter called Grantor, for the consideration hereinafter stated, does hereby grant, bargain, sell and convey unto

hereinafter called Grantee, and unto Grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in the County of **Klamath**, State of Oregon, described as follows, to wit:

A parcel of land situated in the NW1/4 of the SW1/4 of Section 7, Township 39 South, Range 10 East of the Willamette Meridian, in the County of Klamath, State of Oregon, more particularly described as follows:

Beginning at a point on the South line of a public road known as Booth Road which is 121 feet West and 30 feet South of the Northeast corner of said NW1/4 of the SW1/4 of Section 7; thence West along the South line of Booth Road a distance of 120.4 feet to a point; thence South 03°35' East a distance of 280.3 feet to a point; thence South 77°50' East a distance of 105 feet to a point; thence North a distance of 302.3 feet, more or less to the point of beginning.
