RECITALS

Pursuant to ORS 312.100 the said properties on the list attached hereto as "Exhibit B" were ordered sold to Klamath County, Oregon, subject to the right of redemption as provided by law. A General Judgment was entered in the Circuit Court of the State of Oregon for the County of Klamath on September 24, 2013, Case No. 13-00001FR in favor of Klamath County, Oregon, and against Darwin Lee Ake, et al.

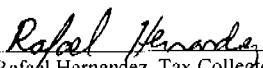

The properties were not redeemed as provided by law.

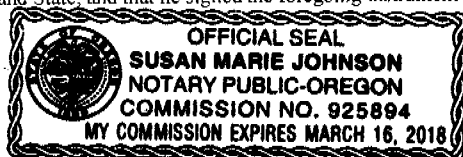
