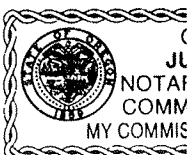

THIS INDENTURE, Made this 9/21/2015, by and between Frank Skrah, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and US BANK NATIONAL ASSOCIATION, AS TRUSTEE UNDER SECURITIZATION SERVICING AGREEMENT DATED AS OF FEBRUARY 1, 2007 STRUCTURED ASSET SECURITIES CORPORATION MORTGAGE PASS-THROUGH CERTIFICATES, SERIES 2007-BC2, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1302616CV, Klamath County Sheriff's Office Number J14-0200, in which US BANK NATIONAL ASSOCIATION, AS TRUSTEE UNDER SECURITIZATION SERVICING AGREEMENT DATED AS OF FEBRUARY 1, 2007 STRUCTURED ASSET SECURITIES CORPORATION MORTGAGE PASS-THROUGH CERTIFICATES, SERIES 2007-BC2 was plaintiff(s) and JEFFREY T. TO HAVE AND TO HOLD the same unto the grantee and grantee's heirs, successors, and assigns forever.

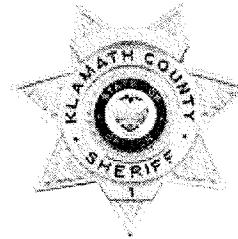
