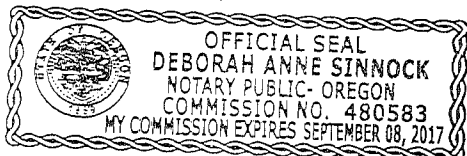

Parcel 1:
