The true and actual consideration paid for this transfer, stated in terms of dollars, is \$zero.

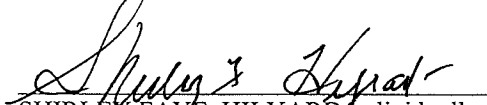

be made so that this deed shall apply equally to corporations and to individuals.

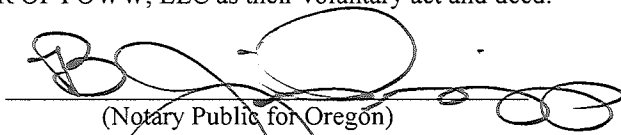
