DESCRIPTION OF PROPERTY

Township 36 South, Range 14 East of the Willamette Meridian:

Section 20: The SWE lying Southwesterly of the O.C. & E. Railroad right of way.

EXCEPTING THEREFROM that portion of Section 20 more particularly described as follows, to wit: Beginning at the intersection of the Easterly line of a County Road, known as Ivory Pine Road, and the Southerly line of the O.C. & E.
