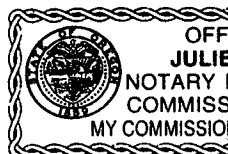

THIS INDENTURE, Made this 11/17/2015, by and between Frank Skrah, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and JPMorgan Chase Bank, National Association, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1400884CV, Klamath County Sheriff's Office Number J14-0216, in which JPMORGAN CHASE BANK, NATIONAL ASSOCIATION was plaintiff(s) and ANDREW L. PETERSEN; ASHLEY R. PETERSEN; OCCUPANTS OF THE PREMISES was defendant(s), in which a Writ of Execution, which was issued on 10/28/2014, directing the sale of that real property, pursuant to which, on 5/1/2015 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$125,600.00, to JPMORGAN CHASE BANK, NATIONAL ASSOCIATION, who was the highest and best bidder, that sum being the highest and best sum bid therefore. 

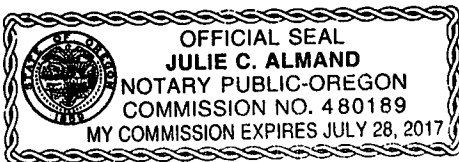


