hereinafter called Grantee, and unto Grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in the County of **Klamath**, State of Oregon, described as follows, to wit:

Parcel 1 of Land Partition No. 5-93, Parcel A of Minor Land Partition NO. 76-82, a portion of Lot 6, Block 2 of "Subdivision of Blocks 2B and 3 of HOMEDALE" - in the E1/2 NE1/4 of Section 11, Township 39 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon.

The true and actual consideration paid for this transfer, stated in terms of dollars, is **\$88,000.00**.
