LEGAL DESCRIPTION

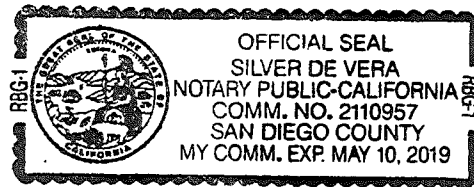
