THIS INDENTURE, Made this 11/17/2015, by and between Frank Skrah, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and JPMORGAN CHASE BANK, NATIONAL ASSOCIATION, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1303005CV, Klamath County Sheriff's Office Number J15-0014, in which JPMORGAN CHASE BANK, NATIONAL ASSOCIATION, ITS SUCCESSORS AND/OR ASSIGNS was plaintiff(s) and JULIE ANN MROSS; AND ALL OTHER PERSONS OR PARTIES UNKNOWN CLAIMING ANY RIGHT, TITLE, LIEN, OR INTEREST IN THE REAL PROPERTY COMMONLY KNOWN AS 608 EAST FIRST STREET, MERRILL, OR 97633 was defendant(s), in which a Writ of Execution, which was issued on 1/13/2015, directing the sale of that real property, pursuant to which, on 5/20/2015 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$91,854.00, to JPMORGAN CHASE BANK, NATIONAL ASSOCIATION, who was the highest and best bidder, that sum being the highest and best sum bid therefore. 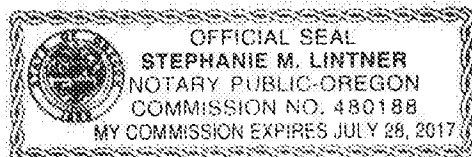


