PARCEL 2:





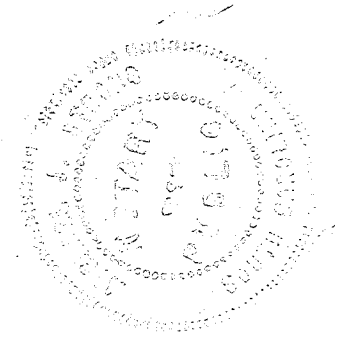
