RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1302978CV, Klamath County Sheriff's Office Number J14-0225, in which PNC BANK, N.A.; ITS SUCCESSORS AND/OR ASSIGNS was plaintiff(s) and PHILLIPS H. THOMAS AS TRUSTEE OF THE PHILLIP H. THOMAS REVOCABLE TRUST; PHILLIP H. THOMAS; BETTY M. THOMAS; AND ALL OTHER PERSONS OR PARTIES UNKNOWN CLAIMING ANY RIGHT, TITLE, LIEN, OR INTEREST IN THE REAL PROPERTY COMMONLY KNOWN AS 4315 MEMORIE LN, KLAMATH FALLS, OR 97603 was defendant(s), in which a Writ of Execution, which was issued on 11/13/2014, directing the sale of that real property, pursuant to which, on 5/8/2015 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$92,250.00, to PNC Bank, N.A.; its successors and/or assigns, who was the highest and best bidder, that sum being the highest and best sum bid therefore. The true and actual consideration paid for this Sheriff's Deed, stated in terms of dollars, is \$30.00.

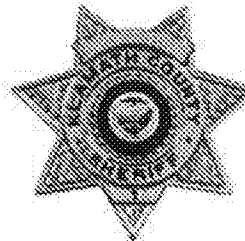

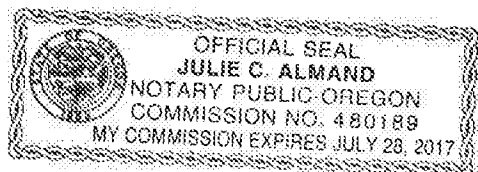


