THIS INDENTURE, Made this 12/29/2015, by and between Frank Skrah, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and Federal National Mortgage Association, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1301432CV, Klamath County Sheriff's Office Number J14-0218, in which ONEWEST BANK, FSB, ITS SUCCESSORS IN INTEREST AND/OR ASSIGNS was plaintiff(s) and UNKNOWN HEIRS OF ORVIN R. KRAMER; O. 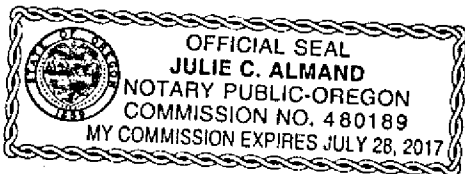


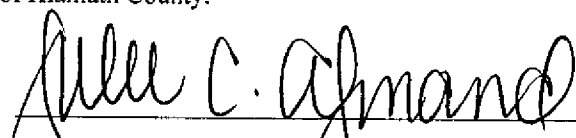
