THIS INDENTURE, Made this 11/9/2015, by and between Frank Skrah, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and Kondaur Capital Corporation, as Separate Trustee of Matawin Ventures Trust Series 2013-1, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1302516CV, Klamath County Sheriff's Office Number J14-01095, in which KONDAUR CAPITAL CORPORATION, AS SEPARATE TRUSTEE OF MATAWIN VENTURES TRUST SERIES 2013-1, ITS SUCCESSORS IN INTEREST AND/OR ASSIGNS was plaintiff(s) and ROBERT LEDBETTER AKA ROBERT D. LEDBETTER; JERI LEDBETTER AKA JERI A. LEDBETTER; ASSET ACCEPTANCE LLC; OCCUPANTS OF THE PREMISES; AND THE REAL PROPERTY LOCATED AT 3209 HILYARD AVENUE, KLAMATH FALLS, OREGON 97603 was defendant(s), in which a Writ of Execution in Foreclosure, which was issued on 10/11/2014, directing the sale of that real property, pursuant to which, on 3/6/2015 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$60,000.00, to Kondaur Capital Corporation, as Separate Trustee of Matawin Ventures Trust Series 2013-1, who was the highest and best bidder, that sum being the highest and best sum bid therefore. 

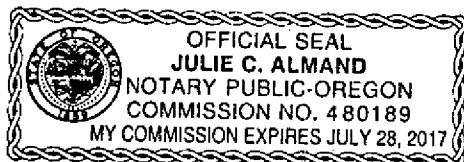



