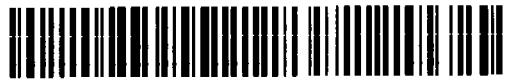

A tract of land situated in the SE1/4 of Section 13, T39S, R9EWM, in the County of Klamath, State of Oregon, more particularly described as follows:

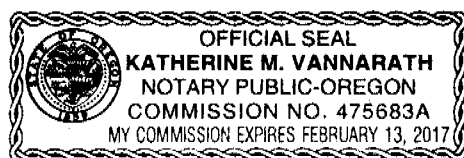
Beginning at a 5/8" iron pin situated on the North right of way line of the County Road known as Airway Drive, said point being North 30.0 feet and East 1504.83 feet from the South quarter corner of said Section 13; thence North 01 degree 07' 45" East a distance of 2349.05 feet to a 5/8" iron pin; thence continuing North 01 degree 07' 45" East 31.00 feet, more or less, to the Southwesterly right of way line of the U.S.R.S. Main Canal; thence South 36 degrees 29' 13" East along said Southwesterly right of way line a distance of 679.79 feet; thence South 01 degree 07' 45" West 30.00 feet to a 5/8" iron pin; thence continuing South 01 degree 07' 45" West a distance of 1803.40 feet to a 5/8" iron pin on the North right of way line of said County Road, said point being 30.00 feet North of the South line of the SE1/4 of said Section 13; thence West along the North right of way line of said county road a distance of 414.96 feet to the point of beginning.
