TRUSTEE'S DEED

THIS INDENTURE, made January 20, 2016, between Northwest Trustee Services, Inc., hereinafter called the Trustee and U.S. Bank National Association, on behalf of the registered Holders of Bear Stearns Asset Backed Securities I LLC, Asset-Backed Certificates, Series 2007-AC1, hereinafter called the second party;

RECITALS: Edward S Rodgers and Julia S Rodgers, Husband and Wife, whose address is 855 Chiloquin Boulevard, Chiloquin, OR 97624 as grantors, executed and delivered to: Amerititle, as trustee, for the benefit of Mortgage Electronic Registration Systems, Inc. as nominee for Central Pacific Mortgage Company, its successors and assigns, as beneficiary, a trust deed dated 10/13/06, duly recorded on 10/20/06 in the mortgage records of Klamath County, Oregon in 2006-021102 and subsequently assigned to U.S. Bank National Association, as Trustee for Certificateholders of Bear Stearns Asset Backed Securities I LLC, Asset-Backed Certificates, Series 2007-AC1 by Assignment recorded as 2012-001878. In the trust deed, the real property described below ("Property") was conveyed by the grantor to the trustee to secure, among other things, the performance of the grantor's obligations to the beneficiary. The grantor thereafter defaulted in the performance of those obligations and such default(s) still existed at the time of the trustee's sale of the Property described below.

Because of the default(s), the record beneficiary under the trust deed or its predecessor declared all sums secured by the trust deed immediately due and owing; therefore, a Notice of Default, containing an election to sell the Property and to foreclose the trust deed by advertisement and sale to satisfy grantor's obligations owed to the beneficiary, was recorded on 08/14/15, in 2015-009286 in the mortgage records of the county in which the Property is located.

Further, the trustee published a copy of the Trustee's Notice of Sale in a newspaper of general circulation in each county in which the Property is located, once a week for four successive weeks; the last publication of Notice of Trustee's Sale occurred more than twenty days prior to the date of sale.
