A parcel of land lying in the NE 1/4 NW 1/4 of Section 18, Township 38 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon and being a portion of that property described in that deed to the State of Oregon, by and through its State Highway Commission, recorded in Book 109, page 505 of Klamath County Records of Deeds; the said parcel being that portion of said property lying Northerly of that property described in that deed to Klamath County, recorded in Book 293, page 143 of Klamath County Record of Deeds.

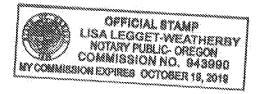
