KNOW ALL BY THESE PRESENTS that ROGER O. HANSEN AND BARBARA D. HANSEN, hereinafter called grantor, for the consideration hereinafter stated, to grantor paid by ROGER O. HANSEN AND BARBARA D. HANSEN, TRUSTEES, OR THEIR SUCCESSORS IN TRUST, UNDER THE HANSEN LIVING TRUST DATED JANUARY 27, 2016, AND ANY AMENDMENTS THERETO, hereinafter called grantee, do hereby grant, bargain, sell and convey unto grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath County, State of Oregon, described as follows, to-wit:

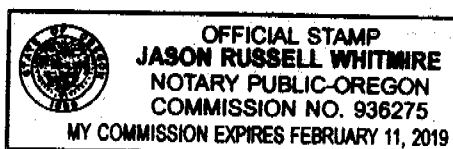


