## **DEED IN LIEU OF FORECLOSURE**

hereinafter called grantor, for \$135,626.03 and the consideration hereinafter stated, do hereby grant, bargain, sell and convey unto WELLS FARGO BANK, N.A. whose address is ONE HOME CAMPUS, MAC F2303-03R DES MOINES, IA 50328 and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereto belonging or in any way appertaining, situated in the County of KLAMATH, State of Oregon, described as follows:

AS NOMINEE FOR GATEWAY BUSINESS BANK, DBA MISSION HILLS MORTGAGE BANKERS and recorded as Instrument No. 2009-004781 on 04/06/2009, of the real property records of KLAMATH County, State of Oregon.
