THIS INDENTURE, Made this 2/25/2016, by and between Frank Skrah, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and Federal National Mortgage Association ("Fannie Mae"), hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1404044CV, Klamath County Sheriff's Office Number J15-0043, in which FEDERAL NATIONAL MORTGAGE ASSOCIATION ("FANNIE MAE") was plaintiff(s) and TOBBY D. MARTINO; KRISTINE A. MARTINO; STATE OF OREGON; KELLIE M. HOWELL; OCCUPANTS OF THE PREMISES was defendant(s), in which a Writ of Execution, which was issued on 3/4/2015, directing the sale of that real property, pursuant to which, on 7/15/2015 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$81,000.00, to FEDERAL NATIONAL MORTGAGE ASSOCIATION ("FANNIE MAE"), who was the highest and best bidder, that sum being the highest and best sum bid therefore. 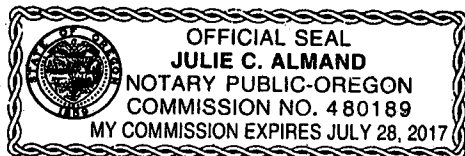

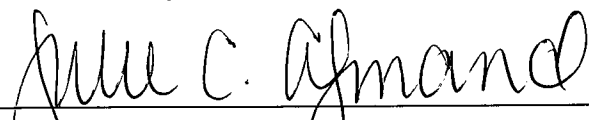
