## QUITCLAIM DEED

KNOW ALL BY THESE PRESENTS that Denis P. Hickey

hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and forever quitclaim unto Lani R. Hickey

hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of the grantor's right, title and interest in that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath County, State of Oregon, described as follows (legal description of property):

A portion of S 1/2 SE 1/4 of Section 2 Township 41 South, Range 11 East of the Willamette Meridian, more particularly described as follows:

Beginning at the quarter section corner common to Sections 2 and 11, Township 41 South, Range 11 East of the Willamette Meridian and running thence North 412 feet; thence continuing North to the North line of the Highway and the true point of beginning; thence along the North boundary of the Highway in a Northeasterly direction 495 feet to a point; thence North parallel to the West line of the SE 1/4 of Section 2 of said Township and Range a distance of 251 feet to a point; thence West parallel to the North line of the S 1/2 SE 1/4 a distance of 375 feet to a point; thence North parallel to the West line of the SE 1/4 a distance of 80 feet to a point; thence West parallel to the North line of S 1/2 SE 1/4, 120 feet to the West line of S 1/2 SE 1/4; thence South along said line 331 feet more or less to the point of beginning.

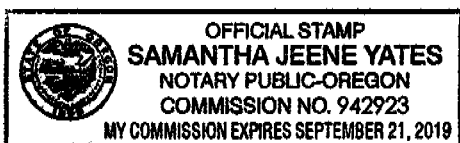
