The true and actual consideration for this conveyance is General Judgment of Dissolution of Marriage.

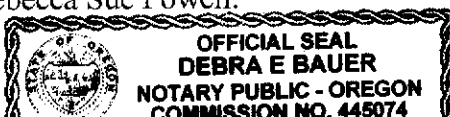
