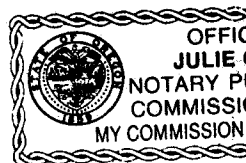

THIS INDENTURE, Made this 2/25/2016, by and between Frank Skrah, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and Federal National Mortgage Association (FNMA), hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1402083CV, Klamath County Sheriff's Office Number J15-0035, in which GREEN TREE SERVICING LLC was plaintiff(s) and PAULA R. LYNCH, JONATHAN M. LYNCH; STERLING SAVINGS BANK; OCCUPANTS OF THE PROPERTY was defendant(s), in which a Writ of Execution in Foreclosure, which was issued on 2/24/2015, directing the sale of that real property, pursuant to which, on 7/8/2015 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$160,600.00, to GREEN TREE SERVICING LLC, who was the highest and best bidder, that sum being the highest and best sum bid therefore. 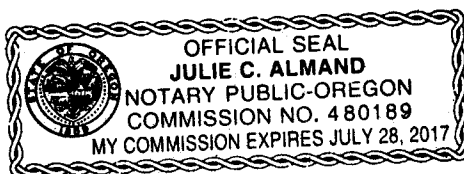


