Darley a distance of 77.8 feet, more or less, (said Course and Distance being described as North 10°57' East 76.2 feet in said Darley Deed, recorded in Volume 342 at page 209) to the South line of the Tract of Land conveyed to John L. Gross et ux., by Deed dated October 12, 1966 and recorded October 20, 1966 in Volume M66 at page 10168 of Klamath County, Oregon Deed records; thence, North 84°42' West a distance of 65.75 feet, more or less, to an iron pin which marks the Southwest corner of said Tract of land conveyed to John L. Gross etux.; thence, continuing North 84°42' West a distance of 75.75 feet to an iron pin; thence, South 7°37' West a distance of 42.73 feet to an iron pin; thence, South 70°35' East a distance of 140.4 feet to the point of beginning.
