ASSIGNMENT OF TENANT'S INTEREST IN LEASE AND ASSUMPTION AGREEMENT

TO HAVE AND TO HOLD the same unto Assignee, its successors and assigns from and after 11:59 p.m., local time, on the date hereof (the "Effective Time").

ASSIGNEE hereby assumes, effective as of the Effective Time, the performance of all terms, covenants and obligations of the Lease on the part of Assignor to be performed under the Lease from and after the Effective Time.

This Assignment of Tenant's Interest in Lease and Assumption Agreement (this "Assignment") is executed and delivered between Assignor and Assignee in connection with the closing of the transactions contemplated in the Purchase and Assumption Agreement, dated as of October 28, 2015 (the "P&A Agreement") between Assignor and Assignee. This Assignment shall be governed by and construed in accordance with the terms and conditions of the P&A Agreement and the laws of the State of New York. Nothing contained in this Assignment shall be deemed to supersede any of the covenants, agreements, representations or warranties of Assignor or Assignee contained in the P&A Agreement or to otherwise alter, amend, supersede or add to the terms of the P&A Agreement. To the extent any inconsistency

exists between this Assignment and the P&A Agreement, the terms of the P&A Agreement shall control and prevail.
