## WARRANTY DEED

KNOW ALL BY THESE PRESENTS that Dan and Katrina Brown husband and wife, as Tenants in the Entirety hereinafter called grantor, for the consideration hereinafter stated, to grantor paid by Wendy L. Gray and Robert J. Gray, as Tenants by the Entirety hereinafter called grantee, does hereby grant, bargain, sell and convey unto the grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath County, State of Oregon, described as follows (legal description of property):

The Southeasterly 55.5 feet of Tract 44 of Homedale, more particularly described as follows: Beginning at the most Easterly corner of said Tract 44; thence Northwesterly along the Southwesterly line of Harlan Drive, a distance of 55.5 feet; thence Southwesterly, parallel with the line between Tracts 44 and 45 of Homedale, a distance of 300 feet; thence Southeasterly along the Southwesterly line of said Tract 44, a distance of 55.5 feet; thence Northeasterly along said line between Tracts 44 and 45 a distance of 300 feet to the place of beginning.

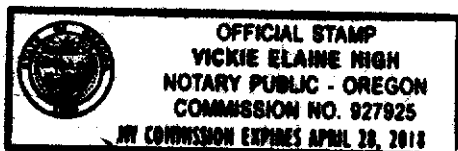
