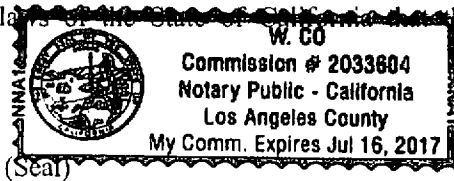

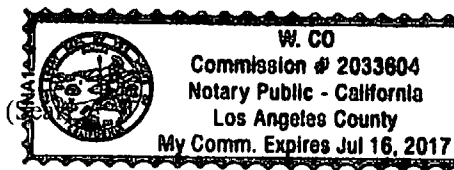


EXHIBIT A
