THIS INDENTURE, Made this 3/24/2016, by and between Frank Skrah, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and FEDERAL NATIONAL MORTGAGE ASSOCIATION ("FANNIE MAE"), hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1403890CV, Klamath County Sheriff's Office Number J15-0081, in which FEDERAL NATIONAL MORTGAGE ASSOCIATION ("FANNIE MAE") was plaintiff(s) and HENRY L. BARNETT; BETHANY N. 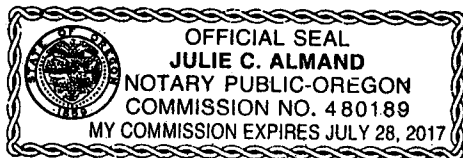


