THIS INDENTURE, Made this 3/24/2016, by and between Frank Skrah, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and FEDERAL NATIONAL MORTGAGE ASSOCIATION ("FANNIE MAE"), hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1404009CV, Klamath County Sheriff's Office Number J15-0083, in which FEDERAL NATIONAL MORTGAGE ASSOCIATION ("FANNIE MAE") was plaintiff(s) and HENRY L. BARNETT; BETHANY N. BARNETT; OCCUPANTS OF THE PREMISES was defendant(s), in which a Writ of Execution, which was issued on 6/1/2015, directing the sale of that real property, pursuant to which, on 8/21/2015 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$58,500.00, to FEDERAL NATIONAL MORTGAGE ASSOCIATION ("FANNIE MAE"), who was the highest and best bidder, that sum being the highest and best sum bid therefore. At the time of the sale, the purchaser paid the amount bid for the property to the grantor or grantor's predecessor in office. After Grantor received funds in the amount bid at the sale, a certificate of sale, as required by law, was duly executed and delivered to the purchaser.



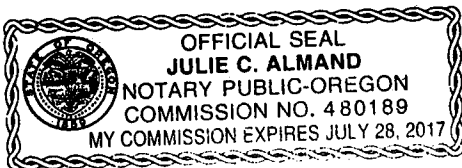


