PERSONAL REPRESENTATIVE'S DEED

THIS INDENTURE Made this 21st day of March, 2016, by and between Theresa Foeller, the duly appointed, qualified and acting personal representative of the estate of Constance Crnkovich, deceased, hereinafter called the first party, and

Greg Felder,

hereinafter called the second party;

WITNESSETH:

For value received and the consideration hereinafter stated, the receipt whereof hereby is acknowledged, the first party has granted, bargained, sold and conveyed, and by these presents does grant, bargain, sell and convey unto the said second party and second party's heirs, successors-in-interest and assigns all the estate, right and interest of the said deceased at the time of the decedent's death, and all the right, title and interest that the said estate of said deceased by operation of the law or otherwise may have thereafter acquired in that certain real property situated in the County of Klamath, State of Oregon, described as follows, to-wit:

A tract of land situated in the SE1/4 SE1/4 of Section 19, Township 38 South, Range 9 East of the Willamette Meridian, in the County of Klamath, State of Oregon, more particularly described as follows:

Beginning at a point from which the corner common to Sections 19, 20, 29 and 30 of said Township and Range bears South 830 feet and East 1330 feet; thence North, parallel to the East line of said SE1/4 SE1/4, 251.00 feet; thence East 363.00 feet; thence South, parallel to said East line 251.00 feet; thence West 363.00 feet to the point of beginning.

The true and actual consideration paid for this transfer, stated in terms of dollars is \$26,000.00. However, the actual consideration consists of or includes other property or value given or promised which is part / whole of the consideration.
