### AMENDED MEMORANDUM OF OPTION AGREEMENT

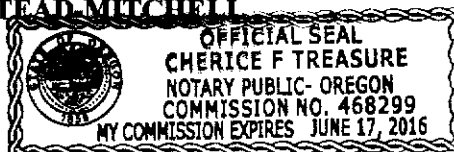
