THIS INDENTURE, Made this 2/29/2016, by and between Frank Skrah, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and Federal National Mortgage Association, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1401832CV, Klamath County Sheriff's Office Number J15-0054, in which FEDERAL NATIONAL MORTGAGE ASSOCIATION ("FANNIE MAE"), A CORPORATION ORGANIZED AND EXISTING UNDER THE LAWS OF THE UNITED STATES OF AMERICA was plaintiff(s) and JOAN E. DEAN; STATE OF OREGON;; UNITED STATES OF AMERICA; OCCUPANTS OF THE PROPERTY was defendant(s), in which a Writ of Execution in Foreclosure, which was issued on 12/23/2014, directing the sale of that real property, pursuant to which, on 8/7/2015 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$80,100.00, to FEDERAL NATIONAL MORTGAGE ASSOCIATION, who was the highest and best bidder, that sum being the highest and best sum bid therefore. 

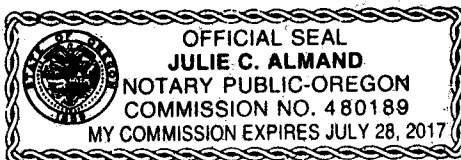


