Commencing at the Northeast corner of the NE 1/4 of NW1/4 of Section 3; thence South along the quarter Section line approximately 380 feet to the North side of U.S. Reclamation Canal "C"; thence Westerly and Northerly along the North bank of said "C" Canal approximately 1200 feet to the point where the said canal intersects with the North Section line of said Section 3; thence East along said Section line approximately 1090 feet to the point of beginning.
