THIS INDENTURE, Made this 3/22/2016, by and between Frank Skrah, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and Washington Federal, National Association, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1500340CV, Klamath County Sheriff's Office Number J15-0084, in which WASHINGTON FEDERAL, A BANKING INSTITUTION, SUCCESSOR BY MERGER TO SOUTH VALLEY BANK & TRUST was plaintiff(s) and FAIRWAY PLUMBING, INC., AN OREGON CORPORATION; AZPED, LLC, AN OREGON LIMITED LIABILITY COMPANY; AND ERIK PEDERSEN was defendant(s), in which a Writ of Execution in Foreclosure, which was issued on 6/11/2015, directing the sale of that real property, pursuant to which, on 8/24/2015 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$142,600.00, to Washington Federal, a Banking Institution, Successor by Merger to South Valley Bank & Trust, who was the highest and best bidder, that sum being the highest and best sum bid therefore. 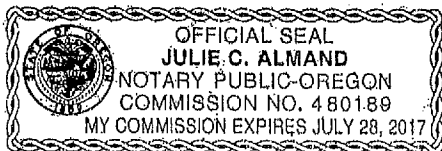


