KNOW ALL MEN BY THESE PRESENTS, That

Modoc Point Properties LLC, an Oregon limited liability company,

hereinafter called Grantee, and unto Grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in the County of Klamath, State of Oregon, described as follows, to wit:

That portion of the SW ¼ of the SE ¼ of Section 15, Township 36 South, Range 7 East of the Willamette Meridian, in the County of Klamath, State of Oregon, lying East of the Easterly right of way of the Southern Pacific Railroad. Less that portion lying within the right of way of the Dalles – California Highway.

The true and actual consideration paid for this transfer, stated in terms of dollars, is no monetary value. However, the actual consideration consists of or includes other property or value given or promised which is the whole / part of the consideration.

To Have and to Hold the same unto grantee and grantee's heirs, successors and assigns forever.
